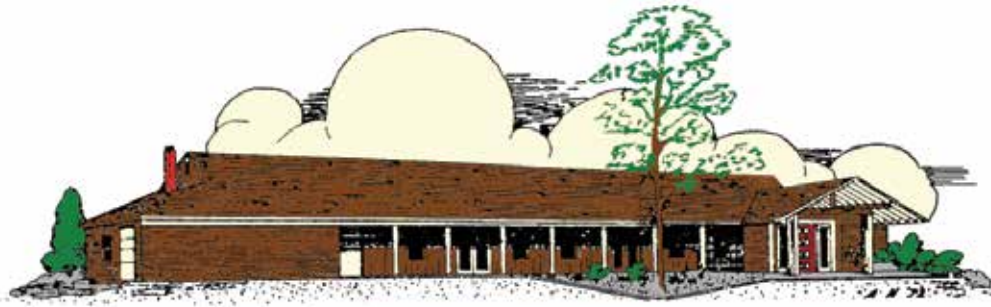

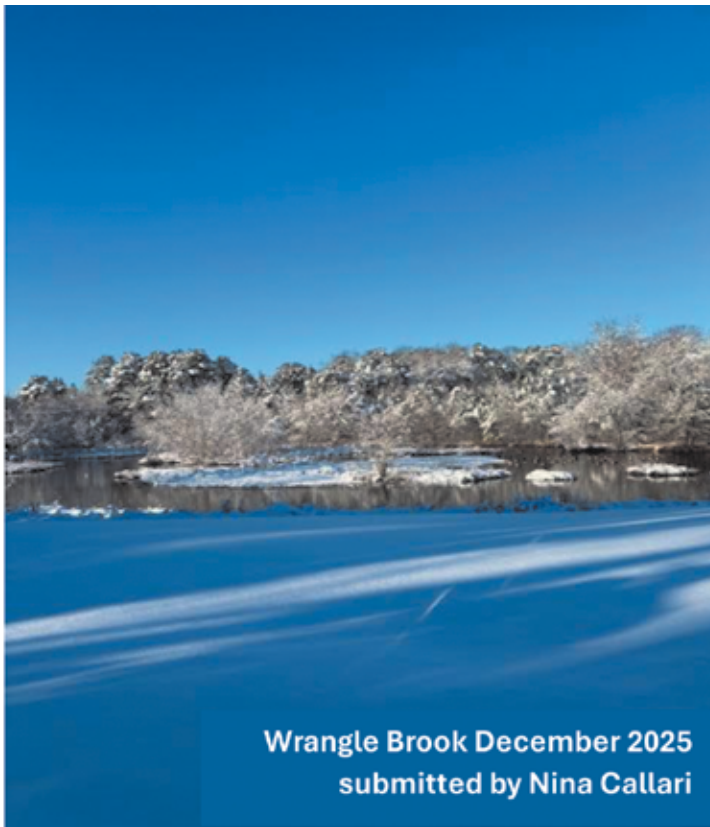

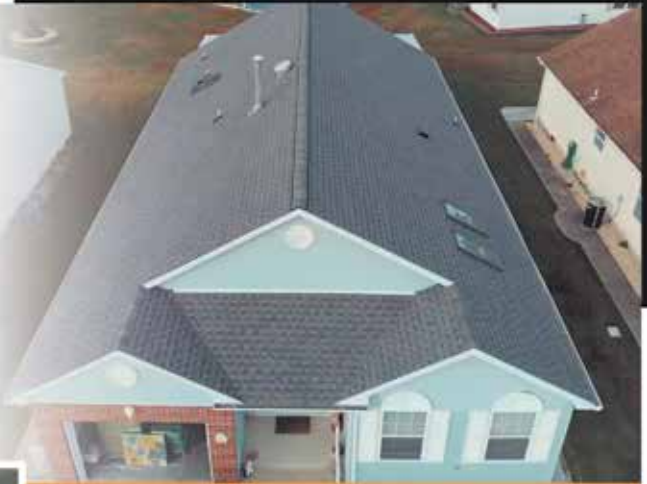

**It's that time of the year for the election of your Officers, Board of Trustees,
and the approval of our 2026 - 2027 Budget**

Early January, you received the proposed SRPE budget ballot for the coming year and a nomination ballot for your Officers and Board of Trustees.

Seriously consider nominating yourself or someone else who is interested in working for our community. There will be ten (10) open Trustee seats on the Board, as well as a President and Vice President.

If you would like to see changes in our community, please join us.

We have scheduled a meeting on February 19th to "Meet the Candidates" to help introduce those on the ballot.

A successful Homeowners Association is only as good as the involvement of the residents. Our current Board feels we have made some positive changes in the last few years, but we need your help to continue to make improvements and fulfill the residents' needs and wants.

**2026 / 2027 BUDGET and CALL FOR NOMINATIONS (Officers and Trustees)
Important dates to remember in 2026 ...**

- January 31 – Budget Ballots and the Call for Nominations are due back in the office by 5 pm.
- Week of February 19 – Election Notice and Ballots will be delivered to your home.
- February 19 – Special Meeting: 'Meet the Candidates' starting at 7 pm.
- March 4 – Election Ballots are due back in the office by 11 am.
- March 5 – Election ballots will be counted, and your new board will be announced at the HOA meeting starting at 7 pm.

Homeowner's Association Meeting
Date: January 8th, 2026

Time: 7:00 pm – 26 residents in attendance.

- I. **Call to Order:** President Phil Cupo called the meeting to order at 7:03 pm
- II. **Roll Call of Trustees:** Present: Darlene DeGennaro, Susan Swain, James Clarke, Kathy Conte, Dave Fuhrman, and Debbie Moriarty. Absent: Mary Fiore
- III. **Pledge of Allegiance**
- IV. **Speaker – Ken Anderson, Berkeley Fire Prevention**
 - A. Ken discussed major causes of fires over the past year, mostly due to cooking in the house and smoking in the garage. He reviewed ways to avoid creating fire hazards in the home. He also indicated that Berkeley Fire Prevention will be taking an increased interest during the coming months in inter-acting with the community by offering training on the use of fire extinguishers and other precautionary measures to take against fire hazards. He emphasized repeatedly that his office is committed to responding to any fire related inquiries homeowners may have and encouraged anyone with concerns to call his office.
- V. **President's Announcements:**
 - A. Phil announced the use of pre-sale inspections, which the Architectural Committee conducts when a home is placed on the market. He said that exterior modifications or other conditions in violation of the Architectural Guidelines stated in the community governing documents must be corrected before a certificate of occupancy can be issued to the new owner. He directed the audience to review Article 7 of our governing documents located on our website if they wish to review these guidelines.
 - B. He announced that the Board, on advice of our Attorney, has decided to pursue foreclosure on homes whose owners consistently refuse to pay quarterly dues and/or violate our governing documents. He added that this action is undertaken on a case-by-case basis and only when it is in the best interest of the community.
 - C. Finally, owners were reminded that the Call for Nominations and the ballot to approve or disapprove the budget have been mailed out. He said that our survival as a self-managed community depends upon homeowners who volunteer to join the Board of Trustees and encouraged everyone to consider becoming a candidate by submitting their name. He said the budget ballot and completed Call for Nominations must be delivered to the office by 5pm on January 31st.
- VI. **Approval of Meeting Minutes:** Motion to approve the Minutes of the December 4th 2025 Homeowner's meeting was made by James Clarke, seconded by Kathy Conte and passed unanimously.
- VII. **Approval of the Treasurer's report:** Treasurer Scott Stern reiterated that insurance costs have undergone an unanticipated increase contributing to a loss of \$10,000 for the month. He also drew attention to the fact that attorney costs as shown in the monthly financial report do not include attorney fees billed to owners. He said attorney fees not reimbursed by owners who incur them adds to the shortfall. Addressing the 2026-2027 budget, he said the Board's efforts to review and correct costs of repair and replacement of certain common elements have resulted in the reduction of our reserve funding requirements. This means that we were able to reduce the budgeted reserve funding for the coming year. Motion to approve the Treasurer's report by Kathy Conte and seconded by Debbie Moriarty passed unanimously.
- VIII. **New Business:**
 - A. **Administrative Report:**
 1. **Real Estate:** Kathy reported 11 properties for sale, 8 under contract, 5 Closings and 1 rental.
 2. **Delinquent Accounts:** She announced \$2,400 in unpaid 3rd quarter dues and \$3,915 in unpaid violations, processing fees and late fees, totaling \$6,315.
\$1,340 in late fees and delinquent dues were paid.
Liens continue on: Cambridge Ct for \$18,430.54; Chamberlain Drive for \$5,043.51, and Chancellor Court for \$14,280.54 for a total of \$37,754.59.
- IX. **Motions:**
 - A. **Architectural Committee approvals:**
Kathy made a motion to approve a fence at 1155 Edgebrook Drive South. She also announced pre-sale inspections passed at 1023 Edgebrook Drive, 1155 Edgebrook Drive, 29 Sherwood Lane and 1111 Waterberry Court and failed at 6 Stanford Drive. Motion was seconded by Debbie Moriarty and passed unanimously.
- X. **Section Reports:** Section 12 reported contacting Animal Control to remove a deer carcass on Edgebrook Drive South. Darlene, Section 1, complimented owners throughout the community for their beautiful Christmas decorations.
- XI. **Club, Committee and Workshop Reports:**
 - A. **Common Grounds and Trees:** Dave reported that the committee is catching up on removing limbs that pose a hazard to homeowners. He said he has had 7 new requests over the last few days.

B. Entertainment, Flea Market and Park Echo:

1. **Entertainment:** Gail announced that there were 107 guests at the Christmas dance held on December 13th, more than at any other event to date. She said funds collected amounted to \$1,551. After expenses, profit for the event was \$835. She said there were at least 3 tables occupied by members of other communities. She announced there will be four events planned for the coming year. Finally, she thanked everyone who helped take down and store the Christmas decorations in and around the clubhouse.
2. **Park Echo:** The Park Echo deadline is Saturday, January 10th. Gail lamented that because the lights were lowered, a minimal number of photos of the Christmas dance could be posted in the upcoming issue. Please continue to send photographs for the Park Echo cover.
3. **Flea Market:** Gail reminded the audience that the last meeting of the Flea Market will be held next week. She said the committee is taking a break due to needing a chairperson and volunteers to help with the considerable work that must be done prior to flea market events.

C. Hospitality Committee: Linda announced that there are treats and coffee to be had after the meeting.

D. House:

1. Debbie announced that she is applying for an energy audit that could result in a possible grant to upgrade some of the equipment and/or to correct structural deficiencies contributing to less-than-optimal energy efficiency in the clubhouse.
2. She also said that the refrigerator was repaired and is working fine.

E. Investment Club: The club has suspended its next meeting due to illness.

F. Pins & Needles: Joy announced that the club meets every Tuesday in the library from 1 to 3pm.

G. Sunshine Club. Elva was not present but later presented a report indicating that she sent out 4 Park Echos to former residents and 2 get well cards.. She continues to request a call when neighbors need a card.

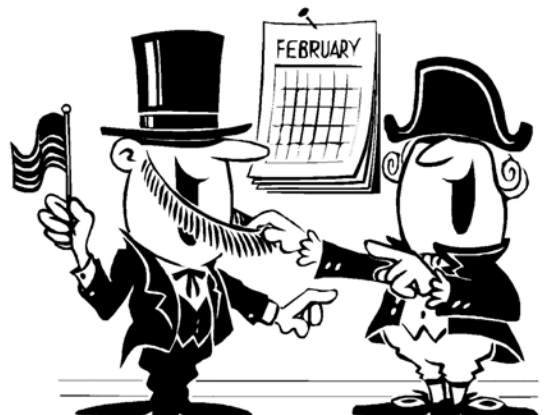
H. The Loss and Grief Workshop: Darlene announced that the workshop ended in December and said that she has not heard of any interest in future workshops at this time.

The speakers will be Gerry Gavin, Director of Business Development and Adam Adelson, Chief Operating Officer of Senior Helpers, a provider of in-home care for Seniors. The next agenda meeting is January 16th at 10am in the library. At 7:40 PM, Phil requested a motion to adjourn the meeting. Motion was made by Jim Clarke, seconded by Kathy Conte and approved unanimously.

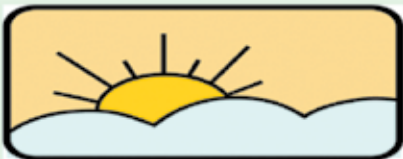


Fire Prevention

For those who missed January's HOA Presentation on Fire Prevention presented by Kenneth Anderson, Fire Official of Berkeley Township, below are important points to consider regarding safety in your home.

- If you smoke, smoke outside. A leading cause of fire fatalities is accidental house fires started by the careless use of smoking materials.
- Plan your escape for your abilities. Practicing how you would escape from a fire before it strikes will enable you to get out faster with less panic.
- Smoke and carbon monoxide alarms save lives. Smoke alarms are the most effective low-cost fire protection devices you can buy. Peak time for home fire fatalities is between midnight and 8am.
- Give space heaters space. Do not purchase unless it contains an 'UL' label (independent testing laboratory). Shut off and unplug when not in use or when you leave the room. **DO NOT USE** extension cords or power strips. There are more home fires during the months of November through March than any other time of the year.
- Stay in the kitchen when cooking. If you leave the kitchen, even for a brief time, turn off the burner. Cooking is the leading cause of home fires and makes up 49% of home fires that occur.

THINGS TO BE AWARE OF WHEN SELLING YOUR PROPERTY

If there is not an approved Architectural Request on file for projects like fencing, decks, sheds, etc., you may be asked to remove them at any time, especially if you are going to sell your house.

The Architectural Committee performs a Pre-Sale Inspection when we are notified a house is put on the market. The Committee looks for things like decks (or any part of, including steps) and fences sticking out beyond the sidelines of the house, fences that are not open slated, rocks or mulch being used as a substitute for grass, work done to the front facade of the house without prior approval, etc.

Just because the problem has been there for years doesn't mean it will be "Grandfathered" and allowed to stay. If there is no prior written approval, it will have to be removed or modified.

If you have not made yourself familiar with what restrictions are in our Governing Documents (Covenants & Restrictions, By-Laws and Rules & Regulations) please download a copy from our website (srpeast.com) in order to save yourself some headaches later.

Fire Pits – What needs a permit and what doesn't?

Because we live in a forested area and to ensure everyone's safety, residents are asked to submit an Architectural Request Form for any fire pit to ensure safe use.

Propane fire pits and chiminea with a screen on the top of the chimney **do not** require permits.

Any other fire pit, either like the one pictured on top or a metal bowl type typically found at Home Depot or Lowes **do require a permit** from the State. These are considered "open burn". Permits are issued by the State Forest Fire Service, and we can supply you with the information.

Initial permits are issued for 30 days and, if in compliance, a 90-day permit will then be issued. The permit can be renewed every 90 days. Please provide the office with a copy of your permit. The size of built fire pit cannot be more than 3 ft. x 3 ft. x 3 ft.

Only seasoned firewood can be burned. No tree branches or other "green wood", no pine needles or any other materials.

The pit must be 15 feet from a structure and be surrounded by 5 feet of clean mineral soil or rock. We hope you find this information useful --- SRPE Architectural Committee

SRPE Association Announcements - Ordinance, Covenants & Restrictions

Noise Limitations

- Non-commercial or non-industrial power tools, landscaping and yard maintenance equipment **shall not be operated** between the hours of 8 pm and 8 am.
Berkeley Township Ordinance 4-27.6 (b1)
- No work of noisy or obnoxious nature should be done on Sunday before 10 am and after 6 pm. Weekdays and Saturdays there is no noise before 8 am and after 8 pm except in case of severe emergency conditions approved by the Board of Trustees. **Contractors of any kind (landscapers, roofers, etc.) are prohibited on Sundays.**
Article 10, Section (u) of SRPE Covenants & Restrictions

SRPE Illegal Home Rentals

The Board has been informed repeatedly that some homeowners are renting their homes without notifying the Association – perhaps to avoid the \$300 fee, avoid age restrictions, or perhaps just plain unawareness.

This is a violation of our Covenants & Restrictions, which state that the Association must be notified before renting; the Tenant must be aged 55 or older; and a home cannot be rented unless you have lived in it for two years as a primary residence.

It is also a violation of Berkeley Township ordinances requiring the owner/landlord to register with the Township, provide an age-approval letter from the Association, and pay a Certificate of Occupancy (COO) inspection fee, total amount of \$95 (2 separate checks made out to Berkeley Township: one for \$55 and the other for \$40).

Fees from house rentals help keep our dues from increasing and help keep your taxes down.

Most homeowners/landlords follow our C&R and Berkeley Township laws, but there are some who do not.

If you see someone moving into a house in our community, please call the office so we can verify that they have complied with these restrictions. The caller's name is always kept confidential.

Please Report Any Changes In Your Household

To keep information on our community current, please notify the Office if there are any changes in your household.

This is necessary for statistical HOPA purposes.

Typical changes would include:

- A new or additional phone number
- A homeowner has deceased or moved from the residence
- A change in occupancy, such as someone moving into or out of the residence
- Deed changes

ATTENTION Delinquent Homeowners

To bring severely delinquent accounts up to date, and upon the advice of the SRPE Attorney, please note the following:

If you are in arrears nine (9) months or longer with your dues payments, you must call the Administrative Secretary to make arrangements to bring your account up to date.

Failure to do so will result in a Lien being placed on your property. Court costs and attorney fees will be added to the amount in arrears. Ultimately you may face foreclosure proceedings on your home.

As of December 31, a total of \$44,894.59 are due. Out of that total: \$37,754.59 (3 liens); \$2,400.00 (24 residents unpaid dues); \$825.00 (reporting error on aging), and \$3,915.00 (miscellaneous, late fees, processing fees, and violations).

The Reserve-A-Ride program is primarily designed to serve routine medical needs of Ocean County residents. Unlike the Fixed Bus Routes, this service does not operate on the basis of a printed schedule, rather routes and pick-up times are developed each day in response to the service requests we receive. All vehicles are wheelchair lift equipped.

Once your reservation has been made, the driver will arrive anytime within 1 hour to 1½ hours of the scheduled appointment time (depending on your travel distance). In accordance with Ocean Ride's Safety Policy, our **Drivers are not permitted to enter your home**, thus we require that you be at ground level for your scheduled pick up.

Riders will be billed via mail, the month AFTER service. Absolutely NO CASH HANDLING on-board the Reserve-A-Ride vehicles.

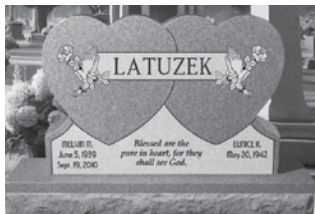

Planning to Sell or Rent?

Read This First!

If you are a homeowner who is planning to put your home up for sale or rent, or if your home is currently for sale or rent without a realtor, you must contact the SRPE office immediately.

There are procedures, required by the Association and by Berkeley Township, that must be followed before a Closing of a Contract of Sale or Lease can take place.

- **Selling:** Article 11, Section 4 of our *Covenants & Restrictions* states, in part, that the owner of the property must notify the Association of the intended sale.
- **Renting/Leasing:** Article 10, Section(c) of our *Covenants & Restrictions* states that the owner of the property must notify the Association, in writing, that the prospective tenant meets the qualifications of membership in the Association.
- Berkeley Township requires a **“Continued Certificate of Occupancy”** (CO). Call the Berkeley Township Code Enforcement Office at (732) 244-7400, ext. 237, for more information.

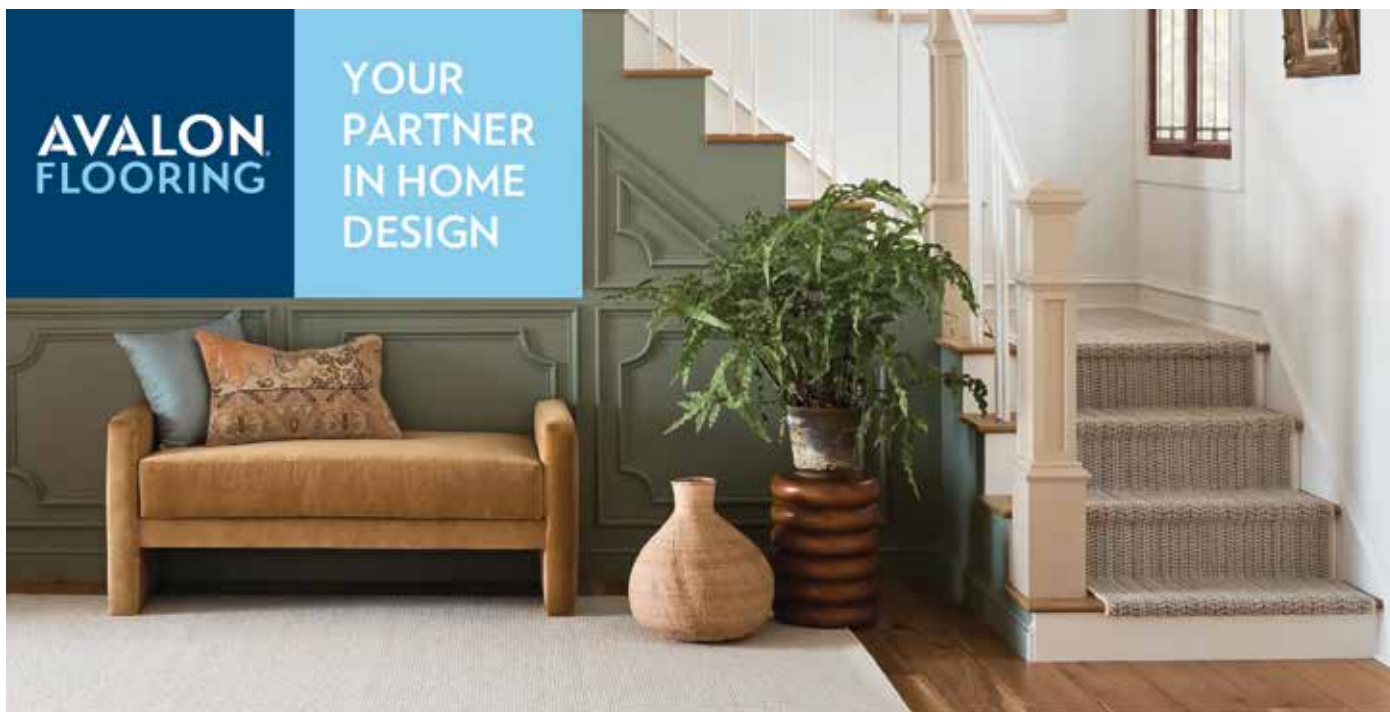
